ADOPTED AMENDMENT TO THE BYLAWS OF  
FISHHAWK RIDGE ASSOCIATION, INC.

Article V, §3 is hereby amended as follows:

§3 Election: Election to the Board of Directors shall be by ~~secret~~ written ballot or by proxy. At such election the Members may cast, in respect to each vacancy, as many votes as they are entitled to exercise under the provisions of the Declaration. The persons receiving the largest number of votes shall be elected. Cumulative voting is not permitted.

Article V, §4 is hereby amended as follows:

§4. Use of Proxy: For election of members of the Board of Directors, Members shall vote in person or by proxy at a meeting of the Members or by a ballot that the Member personally casts, or by casting votes on a proxy card, designating the manner in which the proxy holder is to cast the votes of the absent member.
